Notice is hereby given that Elmsett Parish Council have submitted a draft Neighbourhood Development Plan (the “Elmsett Neighbourhood Plan”) to Babergh District Council under Regulation 15 of the Neighbourhood Planning (General) Regulations 2012 (as amended).

## **The ‘Plan Proposal’**

In accordance with Regulation 16, the District Council will commence formal consultation on the draft Elmsett Neighbourhood Plan on Monday 11 February 2019. Comments are invited on whether the ‘plan proposal’ as submitted (the draft Plan and supporting documentation) fulfils the Basic Conditions as required by Para. 8(1)(a)(2) of Schedule 4B to the Town and Country Planning Act 1990 (inserted by the Localism Act 2011).
